Dear Parents/Guardians,

## **Re: S5 Chemistry Remedial Course 2021-2022**

In order to help S5 students of Chemistry to keep up with their work and prepare for the DSE examination, remedial lessons will be organized for them. Our target students are those who did not obtain satisfactory S4 final examination results in Chemistry. Each student is asked to participate in 5 remedial lessons in the first school term. For these 5 lessons, your child will be provided with a useful learning package at the value of \$450 (the cost of which will not be borne by the student unless he fails to fulfill the requirements stipulated in this letter). Your son will be able to watch the well-prepared explanatory videos of the learning package at his own pace at home under the supervision of his subject teacher via webinar. Following this, your son will be required to submit the finished task the next day to his subject teacher after each lesson at home.

We hope that by providing the students with such extra learning opportunities, they can establish a stronger foundation for their studies. As this is a program especially provided for the students to help them attain better results in the Chemistry DSE, we strongly recommend that your child take part in all the lessons. We will also contact you each time if your child is absent from the course without prior notice or acceptable reasons. Your child may also be charged for the learning package if he fails to achieve 80% attendance.
