Re: 2025 Summer Nanhai Sports Training Camp

The school will be organising a sports training camp in mainland China. The objectives of the training camp are to strengthen participants' physical fitness, foster a positive attitude, cultivate a sense of belonging, and enhance team cohesion among members of our sports teams. During the camp, students will have the opportunity to train at a local secondary school, reside in the school's dormitory, and engage in a variety of cultural and sightseeing activities within the Nanhai region.

Insurance:	<u>Participants are required to purchase personal travel insurance.</u> This insurance should cover the dates from 27 th to 30 th June 2025, inclusive of both dates. Please submit the copy of the insurance policy to the school upon request in due course.
Remarks:	<ol style="list-style-type: none">1. A full payment of HK\$600 is required upon the submission of the reply slip to reserve a place on the training camp.2. Students are required to sign the <i>Rules for St. Louis School Sports Team Mainland/ Overseas Training Camp</i> in order to show that they are committed to the regulations.3. Students will be prohibited from using mobile phones during the training camp. All phones will be collected and kept securely by the teachers.4. In the event of a medical emergency, the school reserves the right to arrange immediate hospital transportation for the student prior to notifying the parents.5. All participants are required to attend the pre-trip briefing. It covers the details of the camp and some key reminders. Details will be announced in due course.
